Directors will take roll for their section and give the roll sheets to the Event Monitors when they are finished. Any students who are tardy will need to check in with the monitors. While breaks are certainly permitted, please provide supervision and assistance as needed during the rehearsal.

Event monitors (*those with an asterisk beside their name) will collect the roll sheets when the students have been checked in. Please keep up with the roll sheets! **Names in *italics* appear on the assignment list TWICE! You have 2 duties!** Event monitors will need to stay with the event until the rehearsal time is over to make sure things go smoothly.

Inappropriate conduct by students will be dealt with in accordance with board policy. Students need to be reminded of expected behavior at an event of this caliber.
